## Minister's Report

Since the last AGM we have tried some new ventures. Not all have worked, but we have been willing to step out and take risks, and we continue to explore opportunities for growth and mission. The Sunday School plan made an encouraging start but faltered really because the children who came (and enjoyed coming) were not as regular as we'd hoped. With the demands and distractions of life for families today, it is tougher making something like this work. I'd like to pay tribute and express gratitude to Tracy, Sue and Gill who were willing to share in the task of leading. Thank you. The plan is officially on the back-burner for now, and one we could bring to the fore again if need and opportunity arise.

In the meantime 'Family Tots' continues as a vibrant and happy group with good numbers attending and a lovely faithful team. I hope there will be a further report penned by someone else. Families come from a wide range of backgrounds reflecting the diversity of families in our area and I believe we are successful in making them feel welcome.

My assembly work continues in all the local authority schools in our pastoral area and I'm thankful that I have this opportunity and pray that seeds are sown of faith and friendship and bear fruit in some way. It is interesting how often the Bible stories I use engage helpfully with the values the schools are trying to build on.

There are occasional opportunities for school groups to visit the church. Children from Downs Barn School (Key Stage 1) have visited and we'll soon expect to host a visit from Brooksward School Key Stage 1. Brooksward Year 6 children enjoy coming to Christmas and Easter Cracked, at which we value church members helping as part of the team. We take the same presentations to Southwood School, but sadly, due to their hall being closed, it looks like it will not be possible to offer them Easter Cracked this year.

At the other end of the age range, monthly services continue at Highclere House nursing home and Neath House dementia care home. Warm thanks to Andrea for the music, which is an essential ingredient, and to Bob, Gill and Dina for your invaluable help.

The Parish Council-sponsored T'n'C (Tea & Coffee afternoon) started in the summer, and continues weekly, mainly enjoyed by retired folk. The Community Mobiliser is exploring injecting some new ideas into this time.

There is a real sense of team work about our Sunday worship, with many different people playing a part, whether with reading, intercessions, refreshments, stewarding, technology and more. The quality of our welcome is vital; we want people to feel welcome and at home, but without pressure. Gwen's noticesheets, faithfully crafted each week, have impressed us with their attractive graphics and layout. Thanks too to Ken for organising our duty rota.

We are grateful for what Chris and Shirley have done in different ways, and sad that Shirley's current health is not

making it possible for them to be actively involved now, but they are often in our thoughts and prayers through this time.

I am deeply grateful for the servant heart of many members, who unstintingly play key roles, both in practical needs and in the pastoral care of members of our family facing illness or infirmity of age. I pray that they'll be encouraged by people coming alongside to help carry the load.

Our Sunday worship depends not just on the home team – myself, Peter (usually once a month) and occasional lay-led services – but also on lay preachers and ministers from the Partnership and wider church. We've enjoyed the variety that affords. Likewise we're grateful to Helen, Beryl and Adrian who've helped on occasions by playing the organ, supplementing Andrea and Bob, our home team.

There was a real encouragement when our Tree Cathedral service at Newlands was well supported by people from other churches in the Partnership and beyond. I counted 35 in all. We were just able to pack up before the rain set in! Another instance of partnership in action was when we hosted an immersion baptism at a morning service, with members of Bradwell Church enjoying the opportunity to join us in worship.

The monthly signed Communion has its own special quality and usually sees a higher attendance. We really have an excellent and dedicated team of signers. Jen has now retired for health reasons from regularly signing, but with Mandy Brownsill and Sue Whalley joining Sue Baines and George Chapman we are well served. We look forward to Bryan and Sue Whalley preaching through BSL at our next signed service in April. The signing team is now trying to meet together monthly to prepare and practise. It's interesting how signing makes you really think about the meaning of the words. The members of our BSL community featured in the most recent (March) edition of 'The Door'.

Once again there was a real buzz and a good crowd at our signed Carol Service in December. Our publicity for that service in recent years has worked well. We long to see more people from the BSL community join us in regular worship – could we make this a prayer priority.

Earlier on the same day as our signed Carol Service we'd held our busy Family Tots Nativity: worship in a very different way but still worship! This year for the first time we hosted Woodlands Nursery, who used our building for their own Nativity. I was highly impressed by the way the children performed and pleased at the welcome given to me to help on that occasion.

Christmas was a good time for us. The flyers I think went out more effectively this year and brought in an encouraging number of visitors to our informal, café-style Family Carols on Christmas Eve. Thank you to Peter once again for leading our Midnight Communion and to Gwen for planning and leading the Advent course which by all accounts was a stimulating time and much appreciated.

Going back a bit further to October, we all cherish the memory of Dina & Peter's wedding, which we combined with our monthly signed service. Dina & Peter wanted the whole

church family to know they were invited, and it worked, with signers and BSL users and families from Family Tots mixing with other members of the congregation and Dina & Peter's friends and family. The church was full of people and full of love and joy. While most people were outside in the sunshine for photos after the service, inside a team beavered away to effect a swift change from worship space to reception venue and we enjoyed a delicious meal together.

Into the New Year we enjoyed food and fun together again for the 30<sup>th</sup> birthday party of the building. Thank you so much to Peter for making that happen.

And thank you too to Mike & Pru for their lovely hospitality hosting our Home Bible study, which started just this year. This has now met four times (more or less fortnightly) and has been an interesting and fruitful time. As we think about what will help us to be a sustainable and growing church, this time of welcome, prayer and study of God's word has to my mind a vital part to play in helping us grow in faith and fellowship.

## Stantonbury Ecumenical Partnership Representatives' Report

The new Minister to join the Clergy Team is Rev. Chukwuemeka Iwuagwu (Chuks for short) who will have responsibility for St Andrews Church in Great Linford. His is a "House for Duty" appointment, which means that Chuks will work three days a week for SEP. He will receive free accommodation in the vicarage and his expenses, but no stipend. Chuks welcoming service was held on 27<sup>th</sup> February 2017.

Helen Rouse, a member of New Bradwell Church and a visiting organist at C & S, has been accepted to train as a Licensed Lay Minister.

Following the Parish Away Day in November 2015, both the SEP Trustees and the separate Churches have been looking at

their Mission and Vision Statements, and how the churches can work together. There was a good attendance at the August Service at the Tree Cathedral. This success depends on support from other church members in the Partnership. It was good to host a SEP Trustees Meeting at the C & S in February, but to do this we have to cancel another user's regular booking.

A Pilgrimage around the Stantonbury Parish has been arranged for 20<sup>th</sup> May 2017. This will be an opportunity to visit the other 5 Churches and to get to meet new people, as well as welcoming them to the Cross and Stable.

The SEP Safeguarding Team consists of a Leader, a rep. from each church and a member of the Clergy. This team have made an application to the C & S Charities for a grant to purchase a lap-top computer and a fixed safe to store it in. The computer will enable DBS checks to be submitted on-line. The safe will be fixed in Christchurch, Stantonbury.

As a member of CitizensMK, the SEP has registered as a "Living Wage Institution". SEP only has one employee who is the Baptist Minister, David Lewis. The Cross & Stable Management Committee also have one employee, the cleaner supplied by our cleaning contractor. They will make sure the cleaner is also paid at the Living Wage rate.

In November, the SEP appealed to the Churches for extra income to help meet all the 2016 commitments. Expenses have increased as, after a gap of over a year, SEP is once again employing a full-time Baptist Minister. If we did not do this, we would still have to contribute to the Baptist Pension fund, to meet payments for previous Baptist ministers. SEP is in a no-win situation! 2017 will have greater expenses as there is an increased demand from Mission Partnership to pay for the Anglican and Methodist Clergy. Any fund-raising ideas would be appreciated!

## Treasurer's Report

The financial records for 2016 were kept as receipt and payment accounts. The figures were prepared monthly and presented to the Officers at bi-monthly Church Meetings.

A sum of £3,052 was received as tax returned on gift-aided donations. We can now claim a gift-aided tax rebate on all cash donations of £20 and less. The final account at the end of December shows that the shortage of receipts against payments was only £211.27.

In 2016 a sum of £10,500 was paid to SEP as our share of the Mission Partnership Quota. It should be noted that this is less than a half share of a minister's salary, without other costs.

£186.50 was collected at the December signed Carol Service and forwarded to the Hearing Dogs for the Deaf People. Our other appeals raised £423.35 for Open Dorr MK and £100 for Bridgebuilder booklets for our local schools.

The amount collected for Christian Aid Week was £538.20 which was paid directly into Christian Aid's account.

Thank you for your generous giving during 2016.

Please continue to support the work and worship at Cross and Stable in 2017.
