- 2. Previous Minutes of the AGM held on 11 March 2012 were agreed and signed after a couple of

Minister's Report

Downs Barn Minister's Report 2013 - 2014

The year just gone has been one of a lot of faithful service by church members in their different roles, some modest growth, one or two experiments, and much that we've continued the same and tried to build on.

I've appreciated the willingness of different ministers, lay and ordained, to help lead worship on a Sunday morning. My aim has continued to be to try and lead roughly every other service and I enjoy the mornings I come to Cross & Stable. The sense of welcome that church members give to everyone who comes is warming and, of course, essential.

Sadly, we have lost one or two faithful attenders at the signed service, including Chris, one of our interpreters who moved up North, but the signing team has a couple of young participants now, and interestingly some new hearing attenders have told me how they really enjoy watching the signers. Jane and I are now half-way through a BSL Level 1 course. I'm finding it quite challenging. I don't make as much time to practise as I should, but I hope it will prove useful in pastoral care for the members of the signing community. Jane excels me and can put me right sometimes!

Back in the early summer, I was approached by our local Sure Start centre about Cross & Stable being a location for an outreach of their 'Family Play'. I was keen that this should be as much as possible a partnership with the church. It took off well, but hadn't been going long when a staff cut at the centre meant they decided they couldn't continue 'Family Play' beyond the end of the summer term. To my joy we were able to expand our number of volunteers from the church and make a team to carry on in a new form with what we now call 'Family Tots'. It's been an exciting venture in all sorts of ways. New people keep coming and numbers have been good. The team, who set up, help with the children and prepare refreshments, has been superb; too many to name here, but thank you to all of them. People have noted the happy atmosphere and it's been a joy to have families from 'Tots' coming along on a Sunday morning and bringing other family members too.

At one time I would tell visiting ministers on a Sunday, 'You may not any children'. Now I tell them it's likely there will be some children and young people. The activities put out at the back of church have been very helpful. In the longer term we need to watch, think and pray about what provision we could make for children on a Sunday morning. One little girl, Ceola

Goldsworthy, was baptised in morning worship in 2013 – a joyful occasion for her family and church family alike.

We have tried some other invitations over the year. The 9.30 am café-style service on 16th June (Father's Day) seemed to work well for those who came, but not many did. Our Cream Tea afternoon did fill the church, with support from our own membership and friends in other churches, and a significant number who responded to leaflets through their doors. At Christmas we again put out invitation leaflets. Thank you to a friend of the church who did all the door-dropping in Downs Barn. Again, there were people who responded and our increased numbers at the Christmas Eve Café Carols and Midnight service were an encouragement. This Easter we will include a late afternoon Good Friday service. It'll be worth us thinking about how we extend an invitation to Good Friday and Easter worship.

I continue to lead a monthly Communion service at Highclere. In the autumn I was approached by Neath Care Home with a request for a monthly service there. This home is for dementia care and so I have tried to develop a service which works in that context. There are a few things in common with our 'Family Tots' worship: songs, visual aids, a simple repeated structure, and 'short and sweet'. Thank you to church members who have come and supported it.

Out in the community I count myself fortunate to be welcomed into all the local (non-sectarian) schools, mainly to do assemblies. I find myself impressed by the work they do, sometimes in quite challenging circumstances, and I'm glad of the contact it gives me with children and staff (and indirectly with parents). Brooksward, Southwood and Downs Barn Schools have visited the church for 'Cracked' presentations and a Harvest service. I continue to assist as part of the steering group of the Conniburrow 'Big Local'. There have been a number of community events and the latest initiative, a community choir, will be led by Bradwell Church members John & Muriel Moffoot. The pressure is now on to construct a plan which has the support of local residents. The plan needs to be about enhancing and building community and is essential for accessing the main body of funding. I have also been approached about serving on the steering group for the Great Linford Parish Neighbourhood Plan.

Back at the Cross & Stable building, the new Pre-School 'Giggles' has begun to build numbers after a slow start. I have been approached about doing a teaching or story time with the children in due course. I hope to make more contact with other users of the building, including other church groups, but haven't made much progress on this score yet, due to pressure of time. HOPE 2014 is an 'umbrella' designed to help churches join together in prayer and mission and I have been commissioned to contact churches in our area about this.

I have yet to conduct a funeral or a wedding at Cross & Stable, but the building provided a good venue yet again for a lovely Marriage Celebration dinner for couples married in the last year or so in Partnership churches. I did conduct 8 services in 2013 at the Crematorium for people from our pastoral area.

The monthly times of prayer and fellowship (jointly with Bradwell Church members) are taking a break for the present as Jill, the main convener, has had a demanding time health-and family-wise. Alice Maynard has agreed to lead and host a 4-week Lent course for us, and I believe one or two Bradwell members may be joining this group – an example of the partnership of giving and receiving. The Alpha course is another example, I hope, of a bit of 'partnership in the gospel'. A couple of 'Cross & Stable friends' are planning to attend the next course, beginning after Easter.

I much appreciate the partnership I feel exists in many aspects of our life: in the pastoral care of congregation members, for instance, and in the care of the building, where members of the Management Committee put in much hard work and to which the Cross & Stable Charities have contributed some significant help recently. I pray that we will continue to partner with each other and with the Holy Spirit, our helper and guide, to serve God with faithfulness and hope and love and vision in the year ahead.

Stantonbury Ecumenical Partnership Representatives' Report

The SEP has had no Minute Secretary since John Figg stood down at the AGM in April. Volunteer needed.

In May, nine delegates from SEP attended a three day conference on the topic of "Leading your Church into Growth". As a result of their enthusiasm, 20 people attended a single day course in October.

In 2013 the Partnership continued its membership of "Citizens MK". It might not be able to continue the financial support in 2014.

There has been little progress on the sharing agreement between the denominations for New Bradwell Church. As soon as one hurdle is overcome the solicitors appear to find another reason for the delay!

The MK Director for Mission, Canon John Robertson gave a series of three Advent talks in the Parish.

Most of the Churches hosted Easter and/or Christmas Cracked Projects for Year 6 children from their local primary schools in partnership with the Bridgebuilder Trust.

The SEP still runs the Tuesday night Soup Run in the city centre and some people also help on other nights. This winter there have been more recipients than before for the soup and sandwiches.

In 2013 the Partnership paid a quota of £129,282 to Mission Partnership, which was £19,000 less than requested. At the end of the year the SEP had used £21,000 of its reserves. They will not be able to do this again in 2014.

The Rev Chris Howden will retire in June. (Her thanksgiving service will be held on June 7th) The SEP hope to appoint another Baptist Minister to replace Chris. The ministers have been discussing how they will provide pastoral care for Christchurch and the Stantonbury area with a smaller clergy team. They have been working on the assumption that Chris' replacement will, on Peter Ballantine 's retirement, need to take on the pastoral care of St Andrew's, though ideas are being explored to see if there are any ways of helping the situation.

Mission Partnership

Rev Canon John Robertson was welcomed as Director of Ecumenical Mission on 28 April 2012 at the Church of Christ the Cornerstone. A reflection and planning day was held on 9 June at Stony Stratford.

Latest priorities for the Partnership include interviewing for an East Flank Pioneer Post; discussion ongoing to enable a Nigerian Church integration with Holy Cross and the Watling Valley Ecumenical Partnership. A job description is being drawn up for an Interserve Fieldworker for the Conniburrow area.

The projet groups are also busy: the MK Environment Group have a meeting on 7 March entitled 'Affordable Warmth' at the Well at Willen; the MK Theology Forum meet on Monday March 11, 7.30pm at The Quaker Centre to discuss 'Love at the Limits: Euthanasia and Assisted Dying'. The Mission Partnership Assembly will meet on 13 March 7.30pm at Whaddon Way Church Centre to hear Rev Dr Roger Paul - the Church of England National Ecumenical Officer - on new approaches to ecumenical work.

Nearer to home on the 9 March 9.30-12.30 (breakfast at 9am) at Christ Church, Stantonbury, Canon John Robertson will facilitate a conversation on 'What's Going On'.

The next Mission Partnership AGM will be on Tuesday 18 June 7.30pm; venue to be arranged.
