### Minutes of the Annual General Meeting of The Cross and Stable Church

### Held on Sunday 11th March 2012

**Present:** The Reverend Paul Smith (in the chair) together with 14 members and friends. Rev Andy Jowitt arrived a little late

### 1. Apologies for Absence

#### 2. Previous Minutes

The Minutes of the Annual General Meeting held on the 13th March 2011 were agreed and signed by Rev Paul Smith, following a few amendments: Heading: Financial Statement 2011. We need to be more careful to get the date of the next AGM correct and changes need to be made asap with everyone being informed.

### 3. Matters arising from the minutes:

9b. The Ringing Recruitment was very successful; over 40 signed up to training sessions. After a 38 year break Cross and Stable may soon have a team of ringers for regular practice and Sunday morning ringing!

### 4. Annual Reports

All the reports for 2011 had been circulated beforehand. Thanks to Peter and Gwen Green for assembling, photocopying and stapling them. There were a few errors: Rev Chris Collinge has been in post 7 and a half years. The financial statement pages will need to be redone. Our minister wished to highlight: the pastoral reorganisation is of major concern to Cross and Stable; the initiative of ministry to the deaf each month is appreciated. There are difficulties of maintaining a presence as a small unit. I commend Andy Jowitt to you all. Paul recommends we help finance the next edition of NETwork for the cost works out at 24p a copy; £1000 for 4,000 copies. As a partnership things can be done together: successes involved the Riding Lights Theatre Group, Christmas Cracked, the Visit of Bishop John Pritchard to give three Advent Lectures; we wish to congratulate Peter Ballantine on becoming a Canon of Christchurch Cathedral, Oxford. We need to check that we

have the Partnership Safeguarding policy in place: Judy Thorp is the new representative. There is a new Methodist/United Reformed Church United Area - for joint ecumenical work together. Amy Head is our representative on this committee. Mission Partnership has positive projects which we can be involved in eg: the Theology Forum and Leipzig/Milton Keynes Link. The photocopier is a definite asset to have.

### 5. Financial statements 2011

A number of errors were discovered and so the two pages 9 and 10 will be amended and brought before the Congregational Meeting in September. However, the corrected pages will be inserted into the Annual Reports for the Stantonbury Partnership AGM on 19 April 2012.

### 6. Membership list

The adoption of the present membership list (dated 31 December 2011) was agreed. A number of extra copies of the list with addresses and telephone numbers will be available to officers, but data protection Act prevents wider circulation

### Downs Barn Minister's Report 2012 - 2013

Minister's Report for Cross & Stable Church, Downs Barn It's now just ten months since I took on the role of minister for Cross & Stable Church. For me one priority was to try and find time to get to know people and to get to know the area. I've very much appreciated the supportive and friendly welcome I've received.

At the time of writing, I'm just back from a Key Stage One assembly at a nearby school. I've been able to visit all the local schools for assemblies on a reasonably regular basis, and am glad that this link with our local community has proved possible. Before Christmas, Year 6 children from Brooksward School came to church for the 'Christmas Cracked' programme and a team including Cross & Stable members took the presentation to Southwood School. It went down very well. Right now dates are being set up for the 'Easter Cracked'

programme.

The situation is of course a new one for all of us as I share my time between two churches and two pastoral areas, and as Cross & Stable develops a link with a different church in the Partnership. For me, there are three morning services to oversee, but only two I can be at on any one Sunday. I personally miss the continuity of seeing people Sunday by Sunday, but I value the different contributions made by people within our congregations and those from the SEP or wider church scene in Milton Keynes who are willing to help. At Bradwell Church a number of the 10.45 am services are now led by members of the congregation, together with a majority of the evening services. More and more, these are the resources churches will depend on to build a sustainable future.

I've appreciated the welcome I've received and know that church members seek to be welcoming to others. The time before and after services is a key part of this. We are not running a Sunday School as such at the moment, but we usually seem to have some children in church and I'm very keen we do our best to help people coming with children to feel at home. Gill has done a great job setting up activities to keep the children happy and busy and I aim to engage them in at least a part of the service. Over these last ten months we have welcomed in baptism two little ones, Bobby and Jack, and one adult: Marion Peters joined in with a baptism and confirmation preparation group at my house and was baptised in the morning at Cross & Stable Church and confirmed in the afternoon at Christ the Cornerstone. A big day.

An important feature of our Sunday worship is the signed service. We have a wonderful team of signers who give of themselves very generously. Sadly, just as we were getting to know Andrew Taylor-Cook in his role as Chaplain for the Deaf community, we learnt that the Oxford diocesan part of his remit was to come to an end. I'd enjoyed working with Andrew and people had quickly taken to him, so it's been sad to say goodbye. We'll have to wait to find out what future plans are for the chaplaincy role.

Next Christmas we'll need to take care that publicity is in place for the Signed Carol Service, and clashes avoided. Though not large, our Christmas numbers were a little up on the previous year. We welcomed in a few visitors and I enjoyed the Crib and Christingle Services the Sunday before and the Café Carols on Christmas Eve, and felt the format worked pretty well. The time around Christmas was a demanding period for me for all sorts of reasons. Peter Green very kindly stepped in to take the service on Christmas morning. I was able to spend some time with my uncle on Christmas Eve (the day before he died) and then, thanks to Peter, gather round my mother's hospital bedside with family members on Christmas Day.

Members of the Stantonbury Partnership play a part in the life of Cross & Stable Church (and members of Cross & Stable Church in the life of the Partnership). With help from musicians from different churches as well as our own, we have been able to enjoy good music each Sunday. Members of Bradwell Church have been eager to build bonds of friendship and fellowship, hence the popular invitation to a Cream Tea last May. One Monday a month people join from the two churches for an hour or so of fellowship and prayer for the

church and the community.

Thinking community, a major boost to one part of our pastoral area will be funding in Conniburrow from the 'Big Local' grant. I have been serving on the steering group for 'Big Local' and have helped out at the community outreach events. I hope we'll see a long-term benefit for the area. "Seek the peace and prosperity of the city to which I have carried you". Jeremiah 29:7

Looking to the future, I ask, "How can we build our church?" Maybe I should be asking, "How does God want to build our church?" I hope that there'll be the synergy for people to meet for Bible study, fellowship and prayer. Gwen has started a day-time Lent course (thank you) and a home-based evening group is a possibility for the future.

The Dragonflies Pre-School closed suddenly in November. The good news is that there have already been enquiries about starting a new group at Cross & Stable. I hope we can also look creatively at new ways for the fine building we have to benefit the community and the mission of the church. Could we establish a parents/carers and tots group? Are there activities that will serve people at the other end of the age spectrum? The international mission agency 'Interserve', which has its HQ at Wolverton Mill South, is in dialogue with the Mission Partnership about a placement, potentially in our area. Could we be a base for a community project led by Interserve? Could our church, or one of the schools in our area, be the venue for a Youth Café on the lines of those established by 'Pulse' at the Brickhills and Walton?

Thinking Sunday worship, we have in mind to try a short All-Age invitation service. We've pencilled in Sunday, 16th June 9.30 - 10.00 am for our first try, and have a kind offer of help with the music.

Finally, I'd like to end with a thank you to the officers and members of the church, who contribute with such good heart to the smooth running of our church and our building. People give sacrificially, not least of their time, and there is a real spirit of service among us.

Those who have helped through the past year, I would like to offer my hearty thanks on behalf of everyone.

### Report from the SEP Representatives for 2012

2012 has been a year of Change, Encouragement and some disappointment for SEP.

Rev Chris Collinge retired from the Parish at the end of March, which leaves Rev Andy Jowitt, Rev Chris Howden and Rev Paul Smith, as full time, and Rev Peter Ballantine, as half-time, Rev Mindy Bell, as part time, (who is currently on maternity leave following the birth of a son), as Ministers responsible for SEP.

Rev Andy Jowitt has taken on responsibility for Cross and Stable together with St Lawrence Church, Bradwell. Rev Paul Smith is now the minister for Willen and New Bradwell Churches.

The Bridgebuilder projects, Easter Cracked and Christmas Cracked have continued with Clergy leadership and plenty of Lay support. The Cross and Stable hosted two classes from Brooksward School and visited Southwood School in Conniburrow.

There was a Lent programme of "Accompanied Prayer" with 11 people taking part.

In November one of our members was baptised at C&S in the morning and she was one of 8 candidates from SEP who were confirmed in the evening.

An excellent copy of the Partnership magazine "Network" was printed and distributed in the spring with sufficient advertising and sponsorship revenue to cover the cost. Unfortunately the editor is unable to continue and there have not been enough offers of help to produce the next edition.

After another year of discussions with Denominations and solicitors the "Sharing Agreement" for St James Church is still not finalised. Until this goes ahead New Bradwell Church is unable to receive any money from the sale of the Methodist Chapel.

We have had notice that SEP lay-chair, secretary and treasurer will all be standing down at the SEP AGM in April. We thank them all, Mike Morris, John Figg and Maggie Prisk for their years of service and pray for the right candidates to take their

place. All Members of the Cross and Stable are invited and encouraged to attend the Partnership AGM on Thursday 18th April at Christchurch.

### **Mission Partnership Report 2012**

Rev Canon John Robertson was welcomed as Director of Ecumenical Mission on 28 April 2012 at the Church of Christ the Cornerstone. A reflection and planning day was held on 9 June at Stony Stratford.

Latest priorities for the Partnership include interviewing for an East Flank Pioneer Post; discussion ongoing to enable a Nigerian Church integration with Holy Cross and the Watling Valley Ecumenical Partnership. A job description is being drawn up for an Interserve Fieldworker for the Conniburrow area.

The projet groups are also busy: the MK Environment Group have a meeting on 7 March entitled 'Affordable Warmth' at the Well at Willen; the MK Theology Forum meet on Monday March 11,7.30pm at The Quaker Centre to discuss 'Love at the Limits: Euthanasia and Assisted Dying'. The Mission Partnership Assembly will meet on 13 March 7.30pm at Whaddon Way Church Centre to hear Rev Dr Roger Paul - the Church of England National Ecumenical Officer - on new approaches to ecumenical work.

Nearer to home on the 9 March 9.30-12.30 (breakfast at 9am) at Christ Church, Stantonbury, Canon John Robertson will facilitate a conversation on 'What's Going On'.

The next Mission Partnership AGM will be on Tuesday 18 June 7.30pm; venue to be arranged.

### Treasurer's Report

The financial records for 2012 were kept as receipt and payment accounts. The figures were prepared monthly and presented to the Officers at bi-monthly Church Meetings

A sum of £2320.37 was received as Tax returned on gift-aided donations.

The final account at the end of December shows that there was a shortage of receipts against payments of - £1949.91

In January 2012 an extra payment of £2000 was made to Stantonbury Ecumenical Partnership from the surplus of £3483.47 during 2011 when £8000 was paid to the Partnership.

£33 was collected at the December signed carol service and forwarded to the Hearing Dogs for Deaf People The loose collection money from the other Christmas Services totalled £340.25. In January 2013 this will be sent to "Embrace"

The amount collected for Christian Aid Week was £260 which was paid directly into Christian Aid's Account.

In March 2012 the Church Bell Fund was made a restricted fund at the request of the C & S Management Committee. They are willing to donate 80% of Bell Ringers rent and donations to this fund. In 2012 this was a sum of £196.80.
